1. CALL TO ORDER / ESTABLISH QUORUM

The Regular Meeting of the School Safety and Security Committee was called to order by Phillip Prasifka, ROISD Chief of Police/Emergency Management Coordinator, at 4:32 pm.

The School Safety and Security Committee met at the Red Oak ISD Education Service Center and the presiding officer, Chief Phillip Prasifka, noted that a quorum of Committee members was present; that the meeting was duly called; and that the notice of the meeting had been posted in accordance with the Texas Open Meetings Act, Texas Government Code, Chapter 551.00.

4. SAFETY AND SECURITY UPDATE

Phillip Prasifka, Chief of Police, Red Oak ISD Police Department

A. Staffing

Chief Prasifka reviewed that there are currently 2 vacancies as of September 6, 2022.

B. Exterior Door Safety Audit

Chief Prasifka reviewed the audit requirements and discussed that the audits are being done weekly and documentation is on file.

C. Summer Targeted Partial Safety Audit

Chief Prasifka reviewed the details of the audit and discussed that this part is complete and on file.

D. Fall Safety Week Review

Completed safety drills on all campuses the week of 8/29-9/2.

E. Safety Training

All district staff and subs have been trained.

F. Mandatory Drills

All drills have been scheduled.

G. Threat Assessment Teams

Most required staff members have completed the training. More training dates have been provided to those who have not completed the training yet. District and campus teams have been formed.

H. Emergency Operations Plan

Chief Prasifka stated the plan is in the process of being updated, and it will be due in October.
